

Is no fault divorce finally here?

Currently the only ground for divorce in England and Wales is that the marriage has irretrievably broken down. To show this a petitioner needs to rely on one of five factors, namely adultery, unreasonable behaviour, two years separation with both parties consenting, desertion or five years separation. According to the Office for National Statistics, unreasonable behaviour was the most common reason for opposite sex couples divorcing with 52% of wives and 37% of husbands petitioning on these grounds.

This figure is particularly worrying as relying on adultery, unreasonable behaviour or desertion means that the petitioner has to place blame on the other party. This is often difficult for spouses, especially when both are in agreement that divorce is the best way forward for them. Placing blame and wrongdoing on the other party can be difficult for families and serves only to increase the level of conflict at what is already a difficult time.

However, at long last the tide appears to be turning and there are strong calls to bring this area of law into modern times.


The Ministry of Justice has recently published a consultation paper on the reform of the legal requirements for divorce. The government is now proposing to remove the necessity to allege fault, something which has long been campaigned by lawyers and various bodies within the legal sector, including ourselves.

The proposals for divorce would retain the ground for the irretrievable breakdown of the marriage but would remove the need for the petitioner to evidence the other spouse's conduct.

The consultation closes on 10th December and who knows, this time next year we could have a new system for divorce in England and Wales which means that divorcing couples do not have to seek to blame one another. **Watch this space!!**

Law in Action

Rowlinsons Property Department recently pulled out all the stops with a new build property purchase, helping a young family save thousands.

Whether you are a first-time buyer or looking to purchase a better property, new-builds are undoubtedly an attractive option. They are often modern, light, contemporary and chain-free so there is plenty to get excited about.

However, from a legal perspective, it is a common misconception that they are much easier to purchase. This is not always the case and new build homes require just as much, if not more attention as a well-built second hand home. A further misunderstanding can happen when a new build property is purchased on a large site of several hundred homes with many of them having already been purchased. Often there is a belief that as the legal work has already been carried out by many different solicitors on the purchased properties, then it shouldn't need to be carried out again for subsequent purchasers. This is a trap that many purchasers and even some solicitors can fall into.

Only this Spring were we able to help a newly married couple with a new born baby. They were living in less than ideal rented accommodation and purchasing a new build apartment from a Developer that we had not previously come across. Our clients were putting all of their hard earned savings and inheritance into the purchase of the apartment and understandably were very keen to purchase the property and move in as quickly as possible.

As soon as we received the legal documentation from the Developers Solicitor we commenced work for our clients. Despite being aware that it was the twentieth apartment in the block to be purchased, we still applied the same high level of due diligence in respect of our legal work as we would for any other type of property.

After careful consideration of the documentation and subsequent meetings with the Developers Solicitors it transpired that we were the only law firm representing a purchaser to correctly identify that the construction of the apartments did not have any initial Building Regulation approval. The initial application by the Developer had in fact been rejected by the Local Authority and we discovered documentary evidence to this effect. It was also the case that Completion Certificates could not be issued on the completion of each individual apartment. This was due to the Local Authority not being satisfied with the method of construction of the apartments and many essential works being left incomplete which the purchasers were not aware of.

Had our clients proceeded without this being identified and addressed, the property could have been unmortgageable and unsaleable. Plus if the property had not been constructed to the correct standards this could have resulted in large repair bills for our clients and possibly the loss of their life savings and family inheritance!

Our work did not end there, however, as our clients were in a desperate position with their new born baby and needed to proceed quickly. We therefore continued to question the Developer who did eventually admit that our findings were correct and owing to the pressure we applied came up with a solution. It was agreed between us, the Local Authority and the Developer that the Developer would return to the site immediately to complete the outstanding works at no expense to the residents. This would ultimately allow our clients' purchase to take place.

This was a great result for our clients (and inadvertently the other residents of the estate!) who were then able to move into the property knowing that it was safe and risk free. Most importantly they were able to enjoy their new home as a family. Despite the fact that twenty other purchasers had been through the legal process, it highlights the importance of appointing an experienced firm of solicitors to handle the legal work. In this instance we were able to save our clients thousands, ensuring they had peace of mind and avoiding the stress and aggravation of having to resolve all the above issues after they had moved in.
